- For a trailer transferred to you: **original** title and Power of Attorney form Notarized
- For a new trailer: **original** certificate of origin and Power of Attorney form Notarized

MAINE SALES TAX AND EIN INFORMATION

If registering under a personal name and have not titled, registered, or paid Sales Tax in your state, you will be required to pay Maine State sale tax of 5.5% n the purchase price of the trailer(s).

If registering under a company name you must provide us with an EIN (Tax ID) number, either a W-9 or a copy of the letter from the US Treasury.
