- For a trailer transferred to you: **original** title and Power of Attorney form Notarized
- For a new trailer: **original** certificate of origin and Power of Attorney form Notarized

MAINE SALES TAX

If registering under a personal name and have not titled, registered, or paid Sales Tax in your state, you will be required to pay Maine State sale tax of 5.5% on the purchase price of the trailer(s).

If registering under a company name you must provide us with a MC # (or Motor Carrier Authority #), an ICC # or a DOT # to be exempt from paying Maine sales tax.
