If registering under a personal name and have not titled, registered, or paid Sales Tax in your state, you will be required to pay Maine State sale tax of 5.5% on the purchase price of the trailer(s).

If registering under a company name, the trailer(s) must be used for interstate commerce. Please provide a MC # (or Motor Carrier Authority #), an ICC # or a DOT # to be sales tax exempt.
